

**Regulations for the Provision of Electronic Services by KOMAN PRODUCTION
within the meaning of the Act on the Provision of Services by Electronic Means:**

What services does KOMAN PRODUCTION provide on its websites:

1. Services on the provision of services by electronic means in accordance with applicable law,
2. Access to information on the basis of the Press Law or the Radio and Television Act, providing Users with access to text, graphic and multimedia materials made available at the individual request of the user in such a way that the user has access to them at a time chosen by them via websites.

Technical requirements:

1. The User is obliged to provide on their own:
 - Electronic equipment,
 - Internet connection,
 - Internet browser,
 - other software required to use selected Services.
2. **KOMAN PRODUCTION** reserves that in the case of some websites, in order to use their full functionality, it may be necessary to enable the SSL secure data transmission protocol, Java Script, Java, Flash and cookies support in the browser.

Prohibition of providing illegal content:

1. It is prohibited to use the Portal in a manner that is contrary to the principles of social coexistence and good customs.
2. It is prohibited for Users to provide content of an illegal nature.
3. Users are fully responsible for the content they enter and for damages resulting from their behavior that is inconsistent with the above reservations.
 - a. The electronic service of comments is a free service available to every Internet user,
 - b. As part of the Electronic Service of comments, KOMAN PRODUCTION provides a form mechanism that allows for the posting of an Entry or Comment with content and form specified by the User, in particular, the User decides what content (text, multimedia content) to enter on the Portal pages,

Complaint procedure

1. Complaints regarding the Services can be submitted in writing, in the form of a registered letter, to the following address: **KOMAN PRODUCTION, 07-201 Wyszaków, ul. Targowa 6** or electronically to the following address: **koman_shop@op.pl**
2. The complaint should include the name of the person filing the complaint (name, surname, address, e-mail address) and a description of the event that caused the complaint.
3. Complaints will be considered within 7 days from the date of receipt of the complaint by **KOMAN PRODUCTION**

Privacy protection

- 1 **KOMAN PRODUCTION** guarantees the Users of **januszkoman.com** the right to choose in terms of sharing information that concerns them.
2. **KOMAN PRODUCTION** fully respects the right to privacy and protection of personal data of Users.
3. **KOMAN PRODUCTION** allows the use of its services in an anonymous manner, however, in order to obtain full access to the content and services offered through the services, it is advisable to register by filling in the available registration forms.
4. Any transfer of information to third parties takes place if required by applicable law, as well as in the following cases:
 - a. after prior consent of the Users, in order to provide a given Service,

Terms of concluding and terminating agreements for the provision of services by electronic means

1. The agreement for the provision of services by electronic means is concluded for a fixed period.
2. The agreement for the provision of services by electronic means is terminated:
 - a. in the case of temporary services, upon leaving the **januszkoman.com** pages
 - b. in the case of services for which separate regulations have been established, the agreement is terminated on the principles specified in the aforementioned regulations.
3. The Consumer Rights Act does not apply to services provided by electronic means for which separate regulations have not been established (no agreement concluded).

Legal notice

1. In matters not regulated in the Regulations for the provision of Services, in particular for the submission of declarations of intent in electronic form, the provisions of the Civil Code and other acts in force in the territory of the Republic of Poland shall apply.
2. The selection and arrangement of the content made available on the Portal pages constitutes an independent subject of copyright protection.
3. The Portal contains works protected by copyright, trademarks and other original content, in particular texts, photos, graphics, sounds, computer programs and multimedia materials.
4. Using the content provided on the Portal pages does not mean that Users acquire any rights to intangible assets to the provided works or databases.
